The main dissemination activities were carried out in conjunction with the 3rd main project meeting, which was held in Milan on 16<sup>th</sup> June. In this opportunity, FPM hosted the interim Transnational Project meeting at its premises, and project partners from SUT (1 member), AWF (2 members), and UZL (3 members) joined the meeting. Considering 3 members from FPM, a total of 9 experts took part in the meeting. After two years of pandemic, it was the first presence event in which there were real moments of confrontation and dissemination since also people attending FPM were able to be informed about the project and share convivial moments with the members of the partnership.

During the meeting, a colourful roll-up specially made with information about the project was exhibited in the main building of Politecnico (the main polytechnical university of Italy), to illustrate SMARTherapy+ project to interested people. The main outcome of the meeting was disseminated by FPM through the institutional social media as detailed in the following.

#### 3. 2 Scientific Events

#### SMARTherapy+ meeting report 3

A Midterm Meeting of the SMARTherapy+ project Partners was held on 16.06.2022 from 9.00am to 1pm personally at Fondazione Politecnico di Milano FPM (Milano, Italy). The meeting was attended by 8 participants representing all project Partners.

FPM as the Host of the meeting, welcomed all participants and SUT as project leader presented the agenda. The course of the meeting with discussion and conclusions was as follows:

- a representative of each Partner presented and discussed activities in the area of dissemination field for the period of December 2021 May 2022, as well as ongoing and planned activities in this area. Joanna Bartnicka thanked all partners for their work and encouraged them to further activities. She also described visit of SUT in the Health Clinic "Pod Tężniami" im. Jana Pawła II medical services cooperative in Ciechocinek (Poland). The aim of the visit was to gain research materials for preparing training contents and to get a cooperation partner in the area of project promotion.
- UzL reported Multiplier Event 2. It should be highlighted that within the ME2 specialists in physiotherapy were the speakers. The Partners agreed that this fact reflected two kinds of project impact: 1) project content can greatly and positively affect the audience (especially the future physiotherapists) because of engagement of various experts who, by their presence, confirmed the importance of the project outcomes for modern physiotherapy; 2) project can have impact on the physiotherapy community and the institutions represented by the invited speakers.

- AWF presented the report of Questionnaire 3. The evaluation period was 1st December 2021 to 31st May 2022. The Partners agreed that it is not possible to evaluate tasks that have just started. For this reason the decision was made to cancel that tasks. They are following 2.6, 2.7, 3.1. Additionally it was proposed to change the schedule moving tasks 2.7 and 3.1 to next month. (It occurred, after next financial report, that it is not possible because AWF reported activities and budget connected to these tasks).
- Each partner presented progression of training content. SUT reminded about open drive available for all the Partners and asked to collect the materials inside. The partners agreed that this way is helpful and makes it possible to study training materials prepared by different Partners, to avoid creation of the similar content or just help each other in preparing the training. It is especially important when one unit is prepared by two partners.

Particularly, the discussion was about using and processing the video materials including case studies inside SMARTherapy+ tool. SUT has obliged to create a form of a table in order to complete data about list of planned case studies (already done or not yet done), and start and end time for preparing slow video. AWF will complete the table and send to FPM that will help preparing slow videos.

UzL proposed to prepare short intro to each video material in order to make a student familiar with fundamental information about gait pathology presented by this video. All Partners agreed for this proposition.

- SUT presented different options of e-learning platform (commercial or non-commercial). Next step is to do comparison analysis. SUT will prepare such an analysis.
- SUT presented most important issues connected to financial part of the project, also reminded about future obligations connected to preparation of reports to European Commission with the use of Mobility Tool+.

The impact part of the project was discussed. SUT highlighted that an important role in impact was presenting by AWF the project aims and assumptions to the Ethical Commission, that agreed for preparing video materials with patients. FPM mentioned about the possibility to spread information about project within Italian Association of Physiotherapy.

In the context of project impact SUT reminded about the planned evaluation of project outcomes by external experts (after implementation of training content to e-learning platform). AWF declared that possible reviewers will be the authorities of The National Chamber of Physiotherapists (KIF) in Poland (KIF is a professional self-government, bringing together all Polish physiotherapists with the right to work as a physiotherapist). Including KIF into external evaluation of SMARThterapy+ educational tool will be a huge part of impact activities taking into account the fact that information about the project could be spread among all physiotherapists in Poland (72.000 beneficiaries).

FPM presented the tasks schedule for the preparation of the Multiplier Event
 3 to be held in the autumn. SUT proposed that the ME3 can have hybrid form
 with online participation of Polish students.

 Study visit to the John Paul II "Pod Tężniami" health resort clinicin Ciechocinek.

On June 6th, 2022 in the John Paul II "Pod Tężniami" health resort clinic the second study visit took place in Ciechocinek. This time the aim of the meeting was to gather materials for the evaluation of the organization of physiotherapist's workplace and the analysis of physiotherapist's body position at work.

The meeting was attended by: representatives of the SMARTherapy+ project: Joanna Bartnicka, Patrycja Kabiesz, Agnieszka Ziętkiewicz, clinic representatives: Agnieszka Lorenc, Rehabilitation Manager, Michal Dylewski, specialist in the Research and Development Laboratory of the Motor System as well as Prof. Magdalena Hagner - Derengowska who is scientifically involved in physiotherapy.

#### Visit programme:

9:00 AM	Meet with the Rehabilitation Manager and discuss the plan for the visit.
9:30 AM	Getting acquainted with the infrastructure of the John Paul II Health Resort Clinic "Pod Tężniami".
10:30 AM	Observation of physiotherapists' work during treatments.
11:30 AM	Conduct an interview with the Rehabilitation Manager to obtain information about the physiotherapist's workday planning in terms of time organization and use of available facilities.
12:00 AM	The physiotherapist's indication of the most frequent forced positions occurring during treatments for patients with gait dysfunction.
1:00 PM	Meeting with the Board of the John Paul II Health Resort Clinic "Pod Tężniami".
1:30 PM	Lunch.
2:30 PM	Completion of the Dortmund List questionnaire developed to identify occupational risk factors for physiotherapists.
3:30 PM	Breaking.
5:00 PM	Dinner and summary of work carried out.

The collected material will be used to develop training materials included in: module 2 Methodological approach to gait physiotherapy, unit 3 Ergonomics and workflow in gait physiotherapy as part of the ongoing SMARTherapy+ project.






